## **SEWER FINANCING**

#### Want to connect to sewer but find it too costly?

Recognizing that connecting to the municipal sewer system can be costly, and yet wanting to encourage residents to connect, Council has passed a Sewer Financing Bylaw. This will allow you to connect to the sewer at this time, and pay the total costs of the connection over a period of 5, 10 or 15 years. The payments will be shown as a separate charge on your quarterly utility billings. The financing is a loan from the District to the homeowner, and will be registered against the title of the property. At the time of applying for the connection, you will be responsible to pay the \$55 plumbing permit fee.

#### How does the financing work?

<u>The financing agreement will be registered against your property at the Land Titles</u> <u>Office in Kamloops.</u> Upon completion of payment, the agreement will be discharged.

- 1. Financing will apply only to the sewer connection fees and the sewer installation costs (excluding plumbing permit fees).
- 2. Interest will be charged at a rate of 1% over prime at the time of agreement.
- 3. A one-time 3% administration fee (to a maximum of \$300) will be charged by the District. This is to cover administration expenses for the financing and Land Titles registration fees.
- 4. The term of repayment can be either 5, 10 or 15 years, at the option of the homeowner.
- 5. The District will finance only a reasonable amount, supported by a properly approved billing from a legitimate contractor.
- 6. The customer has the option at any time during the term of the contract to pay the outstanding balance without penalty.
- 7. If the property is sold while the agreement is still in effect, the total balance owing will become due and payable.

#### Can you give me an example?

Example: Resident A hires a contractor who installs the sewer line from the residence to the curb connection.

Contractor costs	\$2,500
Connection fees to hook-up	\$5,000
Administration fee (3%)	<u>\$ 225</u>
Total amount eligible for financing:	\$7,725

Choosing a payment option of 5 years and using an interest rate of prime plus 1% (3.95% currently) the amount to be added to Resident A's quarterly utility bill (20 payments) would be \$427.54.

## How do I apply?

- 1. Complete the top portion of the attached form.
- 2. Obtain an estimate from your plumber/contractor. (It is recommended that you obtain more than one estimate for the job).
- 3. Bring the estimate to the Finance Department. The amount of financing and the length of term will be determined. The process regarding Land Titles will be explained to you.
- 4. Obtain a plumbing permit (\$55).
- 5. A finance agreement and a covenant will be drawn up and will need to be signed by the homeowner.
- 6. Once the agreement and covenant have been signed, have the plumber/contractor complete the relevant work and submit the invoice for payment to the Finance Department at the Municipal Hall.
- 7. Payments for the financing will automatically be included with your quarterly utility bill.
