Position Summary

The District has a seasonal position available for a general labourer in the Parks Department. This four (4) month position is anticipated to be from early August through November 30, 2025.

Reporting to the Operations Superintendent or Parks Foreman, this position performs a variety of general and specific labour-type duties including the safe and efficient operation of municipal vehicles, small tools and equipment.

Qualifications

- Completion of Grade 12 or equivalent education and relevant experience
- Valid Class 5 BC Driver's Licence and safe driving record
- Ability to comply with and follow safety procedures, legislation, regulations and direction
- Knowledge of safe work practices
- Physical agility and ability to complete duties requiring physical effort
- Ability to work outdoors in a variety of weather conditions
- Proficient written and oral communication skills, and the ability to exercise diplomacy, courtesy and tact
- Ability to work in a construction environment

A Level 1 First-aid Certificate, computer literacy, and traffic control certification are desired. The successful applicant must provide the District with a driving record and criminal record check prior to the commencement of work.

Additional Information

This is a union position, and relevant provisions of the CUPE Collective Agreement pertain. The normal workday consists of a scheduled period of eight (8) hours of work between the hours of 7:00 am and 5:00 pm. The normal work week consists of five (5) such consecutive days in a seven (7) day week. The hourly wage is \$30.87 per hour, plus 17.5% of total earnings in lieu of vacation time, statutory holidays, and benefits. Sick time is afforded in accordance with the provisions in the *Employment Standards Act*.
